

# CES' Leadership Programs – The Next Chapter

We are happy to report that CES had a very productive year, albeit given a few (Pandemic related) challenges, with our leadership programs this year.

Several programs are in place and gearing up for a second year of implementation. These include the First Year Principal Academy (FYPA), the Administrator Leadership Development (ALD), Aspiring Superintendents Academy (ASA), the Superintendents Academy, Board Leadership Development, and a Leadership Series. FYPA and the Leadership Series, new programs in 2020-21, were met with great enthusiasm and success. Both will continue into the 2021-22 school year.

For the coming year, we are excited to launch the First Year Superintendents Academy (FYSA). Participants will be supported by a coach and a mentor. Coaches are recently retired superintendents including TJ Parks, Kirk Carpenter, Dr. Kurt Steinhaus and Dr. Veronica Garcia. Sitting superintendents will serve as mentors, and the new superintendents will participate in a monthly 2-hour session of learning.

The Superintendent Academy, presented virtually this past year, will continue in a hybrid fashion. We'll take advantage of statewide conferences – NMCEL summer conference and the CES Fall conference, among others – to present live sessions.

CES is currently in the process of taking applications for all programs, and applicants will be notified of acceptance in July. We are especially surprised by the number of ALD applicants, more than 75 for Cohort 9! In the past four years of ALD's existence, about 400 folks, interested in becoming school and district leaders, have completed the program and are eligible to apply for an Administrative license.

ASA's 13th Cohort may put the number of participants close to the 100 mark, with more than a third of them eventually becoming superintendents, most of whom remained in their positions long past the typical 3-year average.





We encourage you to watch for the topics, times, and dates of the Leadership Series, a monthly 2-3 hour learning session on current topics. Sessions, presented virtually, are open to any of our program participants as well as other leaders in your district.

We've enjoyed a great partnership with the PED this year and have conferenced regularly on current topics and upcoming professional development opportunities. We plan to continue that partnership in a more purposeful manner this year.

Finally, Evan Grasser, David Chavez and Dr. Gloria Rendon are available to assist districts interested in creating and revising their strategic plans. In addition, Evan and Gloria are facilitating team building and leadership training using the DISC assessment. ## Tip of the Month

Our brains are exposed to around 11 million bits of information per second, yet we can only process a fraction of that. In real terms, we lose productivity when switching too frequently between too many tasks and contexts. This can break down our mental toughness and lead to feelings of frustration and hopelessness.

Taking control of your context means framing your work day as a series of tasks. This includes:

- Checking email at specific times
- Blocking out your calendar for appointments and work sessions
- Putting phone on voicemail
- Setting aside 'blocks' or 'chunks' of time to achieve specific tasks.
- Taking control of your context as best as you can will help filter out unnecessary 'white noise' and keep you focused on goals that matter.




